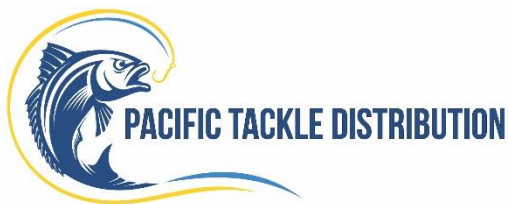

In the event of non-payment of any sum when due or in the event that any representation made to PTD is false when made or furnished, PTD may immediately upon such non-payment or discovery of the falsity of such statement, at its option, without demand or notice to Applicant, declare all indebtedness of Applicant to PTD immediately due and payable, and interest shall accrue from the date of non-payment at the rate of 18% pre annum or the maximum rate permitted by law, whichever is less. Any disputes between the parties shall be litigated federal or state court in San Diego County, California, and Applicant hereby submits to personal and subject matter jurisdiction in such courts. Applicant shall reimburse PTD for all expenses incurred in connection with the collection of any indebtedness owed to PTD including charges made by a collection agent, reasonable attorneys' fees and court costs.

PERSONAL GUARANTY

In consideration of the extension of credit by PTD to Applicant (hereinafter, the "Buyer"), the undersigned (the "Guarantor") does jointly and severally guaranty to pay and be responsible for payment of all sums, balances and accounts due PTD by Buyer, including collection charges and/or attorneys' fees. This shall be an open and continuing guaranty and shall continue in force notwithstanding any change in the form of such indebtedness, or renewals or extensions granted by PTD, without obtaining any consent thereto, and until expressly revoked by written notice from Guarantor to PTD. Any such revocation shall not in any manner affect Guarantor's liability existing prior thereto. Guarantor does hereby waive notice of the acceptance of this agreement, notice of default, notice of non-payment, and furthermore, does hereby waive any action required by any statute. No delay on PTD's part in exercising any right hereunder, or taking any action to collect or enforce payment of any obligations hereby guaranteed, either as against the Buyer or the Guarantor or any other person primarily or secondarily liable with the Buyer, shall operate as a waiver of any such right or in any manner prejudice PTD's rights against Guarantor. Any disputes between the parties shall be litigated federal or state court in San Diego County, California, and Guarantor hereby submits to personal and subject matter jurisdiction in such courts. Guarantor agrees that in the event of any default at any time by Buyer, PTD shall be entitled to look to Guarantor immediately for full payment without prior demand or notice.
